The loan from non-controlling interests repayable after one year are entered into for the financing of the construction of the warehouse in Yangshan Shanghai, China. The loans from non-controlling interests are unsecured.

Finance leases are entered into for certain motor vehicles, trailers, forklifts, lifting equipment and cranes that are secured by the lessor's charge over the leased assets and are secured by corporate guarantee from GKE Corporation Limited ("GKEC") and non-controlling interests.

The borrowings repayable in one year or less and the borrowings repayable after one year comprise the current portion of the borrowings entered into to finance the acquisition of warehouses located at No. 6 Pioneer Walk, 7 Kwong Min Road and No. 39 Benoi Road and the construction of the warehouse in Yangshan Shanghai, China.

The borrowings are secured by proportional corporate guarantee from the GKEC and non-controlling interests, first legal mortgage over the properties located at No. 1 Jalan Besut, 6 Pioneer Walk, No. 7 Kwong Min Road and No. 39 Benoi Road and fixed charged over 100% shareholdings in the share capital of a subsidiary, Van der Horst (Shanghai) Logistics Co. Ltd.

8 (a) REVIEW OF THE PERFORMANCE OF THE GROUP

INCOME STATEMENT

The Group recorded a 30.4% increase in revenue to S\$11.4 million for the three months ended 31 August 2016 ("1QFY17"), compared with S\$8.7 million in the previous corresponding period. This was due to higher revenue contribution from warehousing & logistics segment and maiden contribution from infrastructural materials & services segment.

Revenue for warehousing & logistics segment rose by 24.1% to S\$10.8 million in 1QFY17, compared with S\$8.7 million in 1QFY16. The higher revenue was mainly due to contribution of Marquis Services Pte Ltd ("Marquis") and its warehousing business unit, which was partially undermined by lower contribution from its logistics operations on the back of economic slowdown. Revenue for infrastructural materials & services segment was due to the maiden contribution of S\$0.6 million from its wholly-owned ready-mix concrete manufacturing plant, Wuzhou Xing Jian Readymix Co., Ltd ("Wuzhou Xing Jian"), which has commenced commercial production in June 2016.

Cost of sales increased by 34.1% from S\$6.5 million in 1QFY16 to S\$8.7 million in 1QFY17. The increase was attributable to the additional expenses from the operations of Marquis and Wuzhou Xing Jian, as well as increase in rental expenses.



For 1QFY17, the Group's gross profit increased by 19.7% to S\$2.6 million, compared with S\$2.2 million in 1QFY16. The Group's composite gross margin narrowed from 25.4% in 1QFY16 to 23.3% in 1QFY17.

Other income was lower at S\$0.1 million in 1QFY17 compared with S\$0.2 million in 1QFY16, mainly due to higher gain on disposal of property, plant and equipment and net foreign exchange gain in 1QFY16.

Marketing and distribution costs increased from \$14,000 in 1QFY16 to S\$37,000 in 1QFY17. This was mainly due to higher expenses incurred on marketing for Wuzhou Xing Jian and Van Der Horst Shanghai warehousing operations.

Administrative expenses increased by 3.2% to S\$2.2 million in 1QFY17 from S\$2.1 million in 1QFY16. This was mainly due to increase in staff cost with the addition of Marquis and commencement of Wuzhou Xing Jian operations, which was partially offset by lower depreciation expenses.

Finance costs decreased by 9.1% to S\$0.4 million in 1QFY17. The reduction was mainly due to repayment of borrowings undertaken for working capital purposes, which was partially offset by higher interest rates, hire purchase interest expense undertaken for the purchase of concrete mixer trucks for Wuzhou Xing Jian, and interest expense on loan undertaken for the acquisition of 7 Kwong Min Road property for Marquis.

Other expenses of S\$0.2 million in 1QFY17 was mainly net foreign exchange losses.

The share of results from associates reversed from a profit of S\$19,000 in 1QFY16 to a loss of S\$0.1 million in 1QFY17. This was due to the underperformance of GKE Metal Logistics Pte Ltd ("GKE Metal") on the back of weaker commodities markets.

The profit of S\$0.6 million from its share of results of joint venture came from the chartering of the liquefied gas carrier vessel, Gas Aries.

For 1QFY17, the Group recorded a profit before tax of S\$0.3 million, compared with a loss before tax of S\$0.1 million in 1QFY16.

Taking into account the income tax expense of S\$0.1 million in 1QFY17, the Group recorded a net profit attributable to the owners of the Company of S\$0.1 million for 1QFY17, compared with a net loss of S\$0.1 million in 1QFY16.

Other comprehensive income for foreign currency translation and share of foreign currency translation of associates was a result of translating the financial statements of the foreign subsidiaries and associates financial statement from its functional currencies into Singapore dollars as at the balance sheet date, for the period under review. The movement was mainly due to fluctuations of functional currencies against Singapore dollars.

8 (b) REVIEW OF THE FINANCIAL POSITION AND CASH FLOW OF THE GROUP

STATEMENT OF FINANCIAL POSITION

Non-current assets increased marginally from S\$112.0 million as at 31 May 2016 to S\$113.9 million as at 31 August 2016. The increase was mainly due to increase in property, plant and equipment arising from (i) construction in progress of 39 Benoi Road property, (ii) purchase of fixed assets including motor vehicles and forklift for the warehouses in Singapore and plant & machinery for Wuzhou Xing Jian in China, and (iii) increase in joint venture due to share of its profit, which was offset with the decrease in investment in associates due to dividend received from GKE Metal logistics Pte Ltd and share of its loss.

Current assets decreased by \$\$3.4 million from \$\$43.7 million as at 31 May 2016 to \$\$40.3 million as at 31 August 2016. The decline was mainly due to the decrease in cash and cash equivalents from \$\$30.8 million as at 31 May 2016 to \$\$24.8 million as at 31 August 2016, which can be attributed to the construction of 39 Benoi Road property, the purchase of fixed assets and repayment of borrowings and finance leases with financial institutions.

Non-current liabilities increased by S\$1.1 million from S\$47.1 million as at 31 May 2016 to S\$48.2 million as at 31 August 2016. This was mainly due to an increase in borrowings to finance the redevelopment of 39 Benoi Road property and an increase in finance lease liabilities for the hire purchase of plant & machinery in Wuzhou Xing Jian.

Current liabilities decreased by S\$1.8 million from S\$18.6 million as at 31 May 2016 to S\$16.8 million as at 31 August 2016. The decrease was mainly due to lower trade and other payables, which was offset by the increase in finance lease liabilities attributed to the hire purchases of fixed assets in Wuzhou Xing Jian and for operations in Singapore.

Shareholders' equity decreased marginally from \$\$85.0 million as at 31 May 2016 to \$\$84.3 million as at 31 August 2016, due mainly to a decrease in other reserves.



STATEMENT OF CASH FLOWS

During 1QFY17, the net cash used in operations amounted to \$\$0.4 million. This comprises positive operating cash flows before changes in working capital of \$\$2.1 million, adjusted by net working capital outflow of \$\$2.3 million, interest received and taxes paid of \$\$16,000 and \$\$0.2 million, respectively.

Net cash used in investing activities of \$\$3.2 million was mainly due to the cash outlay for the redevelopment of 39 Benoi Road property, and the purchase of motor vehicles and forklifts offset by the receipt of dividend income from associate of \$\$0.3 million.

Net cash used in financing activities was S\$2.2 million in 1QFY17. This was mainly attributable to the fixed deposit charged with bank S\$2.2 million and repayment of loans and finance leases which was offset by the increase in bank borrowings of S\$1.7 million for the redevelopment of 39 Benoi Road property.

The Group expects the macro business outlook to continue to be challenging amid the global economic slowdown, inflationary costs pressures and intensifying competition to affect the operating performance of the Group.

The redevelopment of 39 Benoi Road warehouse cum office property is in progress and the wholly-owned ready-mix concrete manufacturing plant in Wuzhou, China, currently in commercial production, will ramp up production progressively to meet demand. In view of the prolonged depressed oil prices and increase in the global supply of liquefied gas carrier vessels, it could be challenging for the Group to extend the chartering contract of its liquefied gas carrier vessel.

The Group will continue to monitor and improve its operational efficiency, while it continues to pursue viable strategic business opportunities to broaden stable and sustainable earnings base.
